Description:

The department of Counselor Education completes stake holder surveys every two years, including surveys of students, alumni, site supervisors, and employers of both our School Counseling (SCH) and Clinical Mental Health Counseling (CMHC) program. The data is typically collected in the second year (e.g., 2022) and published in the following year (e.g., 2023). Please note that due to delays from the COVID-19 pandemic, the last published Stakeholder Survey Data was gathered in 2019.

Stakeholder surveys are sent directly to students and employers based on University records. Site supervisor surveys are sent based on the contact information students provide on their field work documentation. Employer surveys are sent by distributing the survey to alumni and asking them to forward it to their employer.





# Q1 As a student at St. John's University, to what extent to you believe that the CMHC counseling program at St. John's University is meeting the following objectives.






# Q4 What campus are you primarily studying on?









# Q6 What semester did you start in the program?




Q5 Did you seek work in the counseling profession after graduation?



## Q6 If you did seek a counseling position, how long did it take you to secure a position after graduation?




