Target: Summer/Fall 2010 Course MGD 120 - Dr. Kevin Rioux Type of assignments: This hybrid (F2F and online) course leads students through a variety of information resources, including encyclopedias, library catalogs, journal articles, literature reviews, bibliographies, books, films, databases, etc. These source types are covered in a series of weekly modules that have students answer a list of short-answer questions and participate in discussions in which they share authoritative information sources that they have found online, in a library, at a government agency website, etc. Students also complete assignments in which they must use a citation manager (e.g., RefWorks, Zotero) to compile, organize, present, and share information resources. These assignments and activities provide measurement indicators to assess student competency in evaluating information resources. Rubric for Measurement: Students demonstrate that they are competent at evaluating information resources when they: a) Correctly identify, retrieve, and competently discuss the given weekly module's information source type. These factors are assessed according to information retrieval and use guidelines presented in the course textbook (Oxford Guide to Library Research by Thomas Mann), and (generally) according to American Library Association information literacy guidelines (http://www.ala.org/ala/mgrps/divs/acrl/standards/informationliteracycompetency.cfm#ilassess). b) Can discuss in an informed way, and share with classmates, information sources that are considered authoritative and useful.
